GENERAL ETHICAL CONSIDERATIONS

Prior to my appointment, a review of ethical issues was undertaken and no ethical threats were identified. A further review has been carried out and no threats have been identified in respect of the management of the liquidation since my appointment.

LIQUIDATOR'S ACTIONS SINCE APPOINTMENT

Following my appointment, my initial assessment of the assignment was that there were no complicated matters to deal with and that I had the staff and resources to proceed with the formalities of winding up the Company.

Since my appointment as Liquidator, my time has been spent as follows:

- Liaising with Accountant and HMRC in respect of pre-Liquidation tax returns
- Liaising with HMRC for clearance in respect of Corporation Tax, and PAYE
- Distribution to Shareholders

RECEIPTS AND PAYMENTS ACCOUNT

My Receipts and Payments account for the period 28 September 2022 to 27 September 2023 is attached.

ASSETS

Balance at Bank

The Declaration of Solvency listed the balance at bank at £447,878.00. I have received funds totalling £304,681.44. The amount received is less than originally anticipated as Corporation Tax was paid prior to Liquidation to HMRC. The Shareholders have confirmed the balance received is correct.

Director's Loan Account

The Declaration of Solvency showed the Director's Loan Account at £262,491.00. The final sum due was £267,931.07. This was higher once the accountant had finalised the balance sheet to the date of Liquidation. This amount has been settled.

Corporation Tax Refund

I received a Corporation Tax Refund from HMRC in November 2022 for £166.24. This was a repayment for the period 1 May 2021 to 5 January 2022.

Bank Interest

During the course of the liquidation, the funds received have been place on an interest bearing account and to date, the sum of £326.60 has been received. Funds are no longer earning interest so that a final Corporation Tax return could be submitted.

LIABILITIES

Secured Creditors

An examination of the Company's mortgage register held by the Registrar of Companies, showed that the Company has no current charges over its assets.

Preferential Creditors

No preferential claims were anticipated, and none have been received.

Unsecured Creditors

The unsecured claims listed in the Declaration of Solvency were £138,657.00. A stated above, this was paid prior to Liquidation.

Corporation Tax was due for the period to the date of Liquidation of £433.90 plus interest. This was paid in December 2022.

DISTRIBUTIONS

The following distributions have been made to members on 31 October 2022:

£1.00 per ordinary A, B and C share. Total distributed £100.00, £100,00, £50.00 respectively. £272.93 per share to ordinary shareholders. Total distributed £272,930.00.

LIQUIDATOR'S REMUNERATION

My remuneration was previously authorised by members at a meeting held on 28 September 2022 on a fixed fee basis of £2,250 plus VAT. This fee has been drawn in full.
