PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

In the space provided below, please insert a general account of the company's activities in the financial year to which the report relates, including a description of how they have benefited the community.

Our Women's Peacemakers Project is targeted at women from other cultures within our community. We have piloted this project in two very deprived areas of the city. It is to enable women to talk about why they feel safe/unsafe and any other concerns that they have about their communities. We are looking for women who are isolated and need befriending. These sessions have been attended by women who have never mixed with others within their community and they have chosen and facilitated the activities and enjoyed craft and Zumba classes. The project has raised the confidence and self esteem of lots of women and improved their health and wellbeing.

We have continued our Enabling Social Action project that has been facilitated by people with disabilities. The aim of the project is to write a charter to give to agencies/companies that use disabled volunteers. The charter will tell the agency/company best practice to use and what is helpful/unhelpful to disabled volunteers. This project has given disabled volunteers a voice to make a difference to their volunteering role.

All the Small Things joined with VAST and Staffordshire University for an event called BCC2 this was a Big Community Conversation held at Staffordshire University. It was a day full of workshops and lots of chances to talk about issues that affect our communities. There was also a section of the event where volunteers were celebrated for their contribution to their community. Everyone nominated got a certificate and gold star pin brooch. This event was attended by over 200 people and everyone learnt something new that they could take away and show others.

Public Health Stoke on Trent have given All the Small Things some funding to run some loneliness workshops. We know that loneliness and isolation is a contributing factor to suicide. These workshops enabled people to start a conversation with people in their communities who they feel are lonely and isolated. There was also information about signposting people to relevant agencies to support them further. The result is that people felt that people cared about them and felt part of the community and gave people the confidence to start a conversation with strangers.

All the Small Things was successful in a grant from Seedbed. This enabled us to start a project called Got It Want It. This is a resource exchange scheme. We want the scheme to be inclusive and volunteers or community champions as we call them have asked if it could be digital. This grant will look at the best platform to use. We currently use this scheme at events and on our Facebook page and have had people sharing lots of resources eg. Gazebos, plant pots and training etc.

Once a year we have a Big Workshop Event. This is attended by over 100 people. At this event we have information stalls and at least 12 workshops. People can attend 3 workshops over the day and there is lunch included. Everyone who attends learns lots of new information that they take back to their communities.

We were successful in an Awards for All grant that enabled us to do some outreach in communities where we know volunteers don't know about our 1000 Lives Project and enable them to be part of the network. 42 people joined the network and have been to our events and supported other people to take social action within their communities

We have a steering group that meets every two months and steers the direction of the 1000 Lives Project which is currently being run by the volunteers of the steering group. We all do small tasks to enable to project to still happen. The meetings are led and facilitated by the volunteers of the steering group and the agenda is set out by them.

We also have a director's meeting every two months which looks at the strategic overview of the company. Halfway through the meeting the associates join us. We are accountable to them and they tell us what they would like us to do and what training and events they would like to see within their communities.

Ultimately everyone who volunteers within Stoke on Trent we call a community champion and they are our stakeholders. They can be part of our network and we are accountable to them to ensure that volunteering is inclusive and that they get the correct support to take social action in their communities.

We use various methods to consult. We send out surveys, use our Facebook page and always consult at every event that we hold. When we do outreach we are always consulting with the community.

Results of consultations are taken back to our Directors/Associates meetings and this guides the direction of our meetings. We then find the funding/resources to enable us to take action.
