The Sheffield Hardware Hackers and Makers CIC (SHH&M) continues to provide a communal workspace and equipment to individuals who are interested in hacking and making. In response to members requirements, during the last year we have increased the capacity of the hackspace by renting the basement underneath our two rooms and have turned this into a woodworking and silversmithing workshop. We have increased also the frequency of our scheduled meetings to every Monday (1800-2100) and extended our opening hours every other Saturday (1100-1800). In addition, we are now running Special Interest Groups for "3D Printing, CNC and CAD", "Radio & Mesh Networking" and "Woodworking" on Friday nights, in order to increase usage of the space across the week and increase our appeal to the wider community. Our membership has turned over and expanded, and we now have 15 keyholder members (24/7 access), 14 regular meetings only members, and mulitple members who turn up on an adhoc basis. Our online membership also continues to grow, offering access to advice and support over emails. As the Hackspace for Sheffield, we have reached out to the local community by attending the Sharrow Festival and Hills Fest, where we included making events for kids. We have also arranged workshops on lasercutting, computer aided design and use of Arduinos (as part of Arduino Day 2016). We have increased awareness of the Hackspace through 1) a successful pitch at the Sheffield Soup crowdfunding meeting, which provided funds for rennovating the basement space, 2) opening up the hackspace during Portland Work Open Days, 3) attendance at Derby Maker Faire and Newcastle Maker Faire and 4) joining Electromagnetic Fields, where members took part in multiple events, such as robot wars and spork making as well as contributing construction skills during set up of the event and stewarding duties. We are also active on the UK Hackspace forum, offering advice to fledgling hackspaces and we have acquired equipment offered from other Hackspaces.

We update members at the first Monday meeting of the month (when most members attend) and then follow this up with an email to the online group. We highlight upcoming events, any administrative items and summarise the current financal status. Members are encouraged to take the lead in key areas, such as attendance at an event, pursuing funding opportunities or networking at specific meetings. Prior to the AGM, items may be raised and discussed on line and where consensus isn't reached, voting may be used to obtain a majority decision.

Our Wordpress site (www.sheffieldhardwarehackers.org.uk) contains all the essential information on our CIC. It has an overview of what we do, our calendar of events and a map of where we are located. In additon, it provides a repository of articles written by members on their making activities. We also have an active Twitter site (@shhmakers) which has increased it's followers by 50% in the last year and currently has 1641 followers. This allows us to share with our followers (who include members as well as other hackspaces and makers both across the UK and worldwide) events and opportunities for funding, networking, as well as sharing information. The Twitter feed also appears on the Wordpress site. Finally, we also communicate with stakeholders via our Facebook pages, which posts new blog articles and also allows new members an additional method of contact.
