Peacemaker Trust Trustees Annual Report

OBJECTIVES AND ACTIVITIES

The charitable purposes of Peacemaker Trust are:

- 1. The advancement of the Christian religion particularly but not exclusively in countries where the Christian faith is a minority by any means as the trustees shall in their discretion determine.
- 2. The promotion of religious harmony for the benefit of the public by promoting knowledge and mutual understanding and respect for the beliefs and practices of different religious faiths.

Peacemaker Trust became a registered charity in January 2017 and was launched on 6th May 2017 at Christ Church, Virginia Water in Surrey. In 2019, the work of Peacemaker Trust has centred on charitable projects in Palestine, Rwanda, Tanzania, Uganda, the UK and the USA.

In June 2019, as part of Refugee Week, Dr Sizer attended an event hosted by Winchester University for refugees and their families organised by several local agencies including the Red Cross, CLEAR and Southampton and Winchester Visitor's Group (SWVG). During June and July, Dr Sizer assisted a mother with three children from Ghana in their asylum application and helped them move to Home Office accommodation in Swansea.

In August 2019, Dr Sizer returned to Arua in North West Uganda to teach and train 70 student leaders and youth leaders in the Diocese of West Nile to use the Christianity Explored course. The Diocese of Arua borders South Sudan in the north and the Congo in the West and is also home to thousands of refugees from both countries who live semi-permanently in sprawling UN camps. Christianity Explored East Africa (CEEA) is working closely with several other mission partners including Scripture Union, the Bible Society, Fields of Life and the Anglican Diocese of Madi and West Nile, led by Bishop Charles Andaku.

Dr Sizer also visited the Anglican Diocese of Kagera in North West Tanzania to train 70 of the clergy to teach others to use the CE course. The vision of the diocese, led by Bishop Darlington and 95 clergy in 53 parishes, is to serve their communities spiritually, physically and mentally. Over 130 lay leaders and youth leaders were trained to use Christianity Explored in January 2018. As a result, over 50 CE courses have been running in the Diocese over the last 18 months. A generous donor has sponsored the printing of sufficient copies of the Swahili CE leaders guide, participants guide and Mark's gospel to resource 700 additional groups in the Diocese in the future.

In October 2019, Dr Sizer participated in the Living Stones of the Holy Land Trust theology group meeting held at Blackfriars in Oxford. Led by Anthony Mahoney of Heythrop College, they discussed the significant theological contribution of the Italian Jesuit priest, Paolo Dall'Oglio. Fr. Dall'Oglio was heavily involved in interreligious dialogue and reconciliation in what became a war zone in Syria. For over thirty years, he was responsible for the transformation of the Monastery of Saint Moses the Abyssinian (Deir Mar Musa), a 6th century complex near Damascus, into a popular inter-faith cultural centre, as well as a hub for the local community concerned with climate change, desertification and sustainable agriculture. In July 2013, Paolo Dall'Oglio was kidnapped in the eastern Syrian city of Raqqa. The area was controlled by the so-called Islamic State at the time. No credible news has been heard of his whereabouts since and it is feared that he has been martyred. Deir Mar Musa is today a place of encounter and prayer, where Muslims and Christians meet in peace, as well as a safe place for internally displaced Syrians, and where Fr. Dall'Oglio's legacy lives on.

Also in October, Dr Sizer attended a training conference together arranged by Welcome Churches, held at St James' Church, Clerkenwell, for churches across the UK supporting refugees and asylum seekers. It was an excellent day of training with speakers from Afghanistan, Iran, Syria, Iraq, Libya and Kurdistan. Their vision is for every refugee to be welcomed by a local church under the simple slogan, "No refugee alone". Welcome Churchesprovides training to help better understand the refugee experience and for churches to help refugees and asylum seekers apply for leave to remain, with resettlement and integration. Welcome Churchesalso facilitates a national referral system to help refugees find a local church in their area, as well as training, support and connection with other Welcome Churches. Dr Sizer attended seminars on immigration law and trauma care as well as self-care for those working with refugees.

In November 2019, Dr Sizer spoke at the 10th International Kairos Palestine conference in Bethlehem. About 350 people attended the one-day conference and about 100 stayed for two days strategic planning on the future of Kairos. Dr Sizer gave a presentation on significant developments within the Evangelical movement in relation to Palestine over the past ten years.

Following the Kairos conference, Dr Sizer also attended the Sabeel International Gathering attended by about 150 internationals and contributed to the conference closing statement.

In December 2019, Dr Sizer completed his training to become a visitor for Southampton and Winchester Visitors Group (SWVG), a charity that supports refugees and asylum seekers in Hampshire. Dr Sizer was also appointed a trustee of the charity in December. He assists SWVG on a weekly basis, welcoming asylum seekers at a drop-in centre held at the Avenue Multicultural Centre (AMC) in Southampton in cooperation with the Red Cross and CLEAR.

Also in December, Dr Sizer was appointed a trustee of Living Stones of the Holy Land Trust, an ecumenical charity with the primary aim of advancing education about Christianity in the Holy Land and countries around, by raising awareness in Britain and elsewhere, educating and informing the public concerning Christians in the Holy Land.

In January 2020, Dr Sizer gave a presentation on 'War and Peace in the Middle East' for the Gulf Cultural Club, held at Abrar House, a Muslim centre in West London. He also spoke on three occasions at Christ Church, Virginia Water, as Peacemaker Trust was their mission partner for January.

In the latter half of January, Dr Sizer was the principal speaker at the annual Goshen Bible Convention held near Luweero in central Uganda. Over 750 pastors from a wide area participated. Dr Sizer delivered a series of sermons on "Jesus: Mean and Wild" based on Mark's Gospel. He also participated in the Kiwoko Bible Institute student graduation ceremony. KBI helps train pastors in ministry in conjunction with Africa Renewal University in Kampala.

Dr Sizer also spoke at a three-day conference for staff at Kiwoko Hospital and Nursing School in Luweero, Uganda. Around 120 staff attended. He gave several presentations on "Biblical Answers to Life's Difficult Questions."

During the last week of January, Dr Sizer travelled to Gulu, the most northern town in Uganda close to the border with South Sudan. He and two colleagues from Bangor were hosted by the Bishop of Northern Uganda, the Right Revd Johnson Gakumba. Dr Sizer helped to train 65 of his clergy to use the Christianity Explored course. He also met with several of Bishop Johnson's staff to explore how best to support their ministries in what is a very poor and challenging region of Uganda.

During the year, on a weekly basis, Dr Sizer has been assisting with an English language café run by Above Bar Church in Southampton. The clients are international visitors and mostly asylum seekers and each week the leaders take it in turns to organise an hour of creative language instruction.

In March 2020, Dr Sizer made a delivery of 15 boxes of theological books, collected from all over Hampshire, for the Book Aid Charitable Trust. In the 1980s a desperate plea came from Africa and other countries where economic crises and foreign currency restrictions had reduced supplies of Christian books to an all-time low. Book Aid Charitable Trustwas set up in order to make large shipments of new and second-hand Christian books and Bibles to these needy areas. In particular Book Aid supports Christian bookshops, mainly in Africa, Asia and the Caribbean.

Due to the to the outbreak of Covid-19, a number of Peacemaker projects scheduled for March to May had to be postponed. These included participation in an ongoing reconciliation initiative between the religious and political parties of Northern Ireland based in Rostrevor, and a week of theological teaching at Kagera Christian Theological College in Tanzania.

Because of the restrictions placed on travel by the government, Dr Sizer has concentrated on promoting partner projects through the Peacemaker website and email. These included Surfers not Street Children, South Africa; Bethlehem Bible College; the Wi'am Conflict Resolution Centre, Bethlehem; Creation Care; The Lausanne – World Evangelical Alliance's Sustainability Centre and Tearfund's 'Renew our World' initiative.

During May, Dr Sizer created a new website for the partner charity, Living Stones of the Holy Land trust, of which he is a trustee www.livingstones.ngo

In planning the activities for the year, the trustees reviewed the guidance on public benefit issued by the Charity Commission.

The trustees affirm the Five Marks of Mission, first developed by the Anglican Consultative Council in 1984 and since then widely adopted as an understanding of what contemporary Christian mission is about. The marks were adopted by the General Synod of the Church of England in 1996 and many dioceses and other denominations use them as the basis of action plans and creative mission ideas. In 2012, the ACC added wording to the fourth mark, to include the need for Christians to challenge violence and work for peace. - To proclaim the Good News of the Kingdom - To teach, baptise and nurture new believers - To respond to human need by loving service - To seek to transform unjust structures of society, to challenge violence of every kind and to pursue peace and reconciliation - To strive to safeguard the integrity of creation and sustain and renew the life of the earth.

The trustees understand their charitable purposes in these terms and seek to be catalysts for peacemaking, especially where minorities are persecuted, where justice is denied, human rights are suppressed or reconciliation is needed. They also affirm the Nicene Creed as a doctrinal statement.

ACHIEVEMENTS AND PERFORMANCE

In 2019, Dr Sizer has visited several countries where minorities suffer discrimination, human rights are denied or where there is considerable religious and civil unrest.

The focus of his charitable work in 2019 has been the promotion of the evangelistic course, Christianity Explored, equipping and training church leaders to use the course in Uganda, Tanzania, Kenya, Rwanda and Burundi.

Dr Sizer has also spoken in seminaries and churches in Palestine and USA giving a Christian perspective on conflict resolution and peacemaking.

The promotion of Christian beliefs and values, especially the focus on peace and reconciliation, will, it is hoped, have a positive and constructive impact on mental health, family harmony and social cohesion.

Dr Sizer has also been exploring future partnerships with other charities and NGOs who share the charitable purposes of Peacemaker Trust.

STRUCTURE, GOVERNANCE AND MANAGEMENT

The trustees have developed a Risk Assessment Matrix based on Risk Assessment for Charities from the Institute of Risk Management. The matrix is used to evaluate the risks associated with project proposals.

The Trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Companies Act 2006. The Trustees are also responsible for safeguarding the assets of the charity and hence taking reasonable steps for the prevention and detection of fraud and other irregularities.

The above report has been prepared in accordance with the provisions applicable to companies subject to the small companies regime as set out in Part 15 of the Companies Act 2006 and in accordance with the Charities SORP (FRS 102).

Basis of preparation

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

Change in basis of accounting or to previous accounts

There has been no change to the accounting policies (valuation rules and method of accounting) since last year and no changes have been made to accounts for previous years.

Recognition of Expenditure is recognised on an accruals basis. Expenditure includes any VAT which

expenditure cannot be fully recovered, and is reported as part of the expenditure to which it

relates.

other administration costs.

Other expenditure These are support costs not allocated to a particular activity.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Tangible fixed assets and depreciation

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life:

Trade and other debtors

Trade and other debtors are recognised at the settlement amount due after any trade discount offered. Prepayments are valued at the amount prepaid net of any trade discounts due.

Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other short-term highly liquid investments with original maturities of three months or less and bank overdrafts. In the statement of financial position, bank overdrafts are shown within borrowings or current liabilities. In the Statement of Cash Flows, cash and cash equivalents are shown net of bank overdrafts that are repayable on demand and form an integral part of the company's cash management.

Trade and other creditors

Short term creditors are measured at the transaction price. Other creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

Peacemaker Trust Notes to the Accounts

Foreign currencies

Monetary assets and liabilities denominated in currencies other than the functional currency of the charity are translated at the rates of exchange prevailing at the end of the reporting period. Transactions in currencies other than the functional currency of the charity are recorded at the rate of exchange on the date that the transaction occurred.

All exchange differences are are taken into account in arriving at net income/expenditure.

Pension costs

The charity operates a defined contribution plan for its employees. A defined contribution plan is a pension plan under which the company pays fixed contributions into a separate entity. Once the contributions have been paid the company has no further payments obligations. The contributions are recognised as expenses when they fall due. Amounts not paid are shown in accruals in the balance sheet. The assets of the plan are held separately from the company in independently administered funds.

2 Company status

The company is a private company limited by guarantee and consequently does not have share capital. Peacemaker Trust (formerly Peacemaker Mediators) is a private company limited by guarantee incorporated in England and Wales. The registered office is 25 Gordon Road, Windosr, Berkshire, SL4 3RG.
