0282 CIC have facilitated various projects surrounding the themes of community, creativity and well-being. Over the last couple of years, the format of activities has changed as a result of the pandemic, and so many of our events have been hosted virtually. These have started to happen in person again, with limited numbers and risk assessments to ensure the healthy participation of vulnerable people. These have included one to one wellbeing sessions addressing individuals mental health concerns that have been amplified by the series of UK Lockdowns. The delivery of these sessions has focused on empowering users and promoting self advocacy to reduce the strain on existing services whilst simultaneously giving individuals the confidence and skills to take control of their own wellbeing. We find this approach to be the most beneficial to our community, as feedback has suggested that many feel put off by the overly medical and prescriptive care models that already exist and so find our support easier to access and engage with. In addition to this, we have facilitated a number of wellebing walks and combined this activity with a photography project to bring the community together to celebrate our local area. This has also served to reduce isolation; as much like our project which promotes connectivity amongst older generations, it has been a chance for people to interact with others during these challenging times.

Further to this, 0282 are working on a number of employability projects in a bid to

encourage young people to explore their potential within less conventional careers. For example, we have been partnering with a local college to help build individuals CV's and portfolios as well as to develop their creative talents and to show that there are viable career options within the arts. This has been part of a wider creative effort we have made, which has included hosting writing, photography and music events, as well as producing our own quarterly zine, podcast and YouTube content.
