#### 1. Principal Accounting Policies

#### **Basis of Accounting**

The Charitable Company is exempt from taxation on its charitable activities.

#### 3. Incoming Resources

The total turnover of the company for the year has been derived from its principal activity wholly undertaken in the UK.

#### 4. Company limited by Guarantee

The charity is a company limited by guarantee and has no share capital. The liability of each member in the event of winding up is limited to £1.

#### 5. Control

The company is incorporated for charitable purposes and has no controlling party.
