1 Statutory information

Richard Edgar Barbering Limited is a private company, limited by shares, registered in England and Wales, registration number 11145116. The registered office is 345a Torquay Road, Preston, Paignton, Devon, TQ3 2EP.

2 Director's advances, credit and guarantees

Included within current assets is a loan to the director, Mr R Edgar. The balance at the year end was £9,224 (2021 £7,849). Interest was payable on this advance at the official rate of 2.25% and 2.00%.

3 Average number of employees

During the year the average number of employees was 1 (2021: 1).

For the year ending 31 January 2022 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies. The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.

The director acknowledges his responsibilities for complying with the requirements of the Act with respect to accounting records and the preparation of accounts.

These accounts have been prepared in accordance with the micro-entity provisions of the Companies Act 2006 and FRS 105, The Financial Reporting Standard applicable to the Micro-entities Regime.
