THAT, conditional upon and simultaneously with the passing of Resolution 1, in accordance with section 570 of the Act, the Directors be generally empowered to allot shares in the Company or to grant rights to subscribe for or to convert any security into shares in the Company referred to in, and pursuant to the authority conferred in, Resolution 1 above without having regard to any rights of pre-emption in favour of shareholders under section 561 of the Act, the Company's existing articles of association, any shareholder agreement relating to the Company or otherwise and any pre-emption rights however arising be waived in connection with the issue and allotment of the shares referred to in Resolution 1 above.
