The company organises a craft beer festival over four days, once a year. The aims of the beer festival are to provide a community event for the village of Willingham and the surrounding area, and to raise funds from the entrance fees which are then donated to local charities or community groups.

This year there were about 1500 visitors to the beer festival. We provided around 60 craft beers and ciders, some from local producers and some from further afield along with live music, morris dancing and food trucks.

In total, we raised £3600 for charity. Half of this was donated Over Day Centre, who provide adult care to local residents and the other half was donated to Willingham Youth Trust who run a youth centre in the village and provide activities and events for younger local residents.

The directors of the company are all local residents, and include a publican who runs a pub in the village specialising in craft beer, and another resident who runs a craft beer distribution company and has extensive experience of organising beer festivals. We have developed the festival using our experience and local knowledge and have discussed our plans with our parish council and village residents who would be likely to attend our festival.

No formal consultation has taken place, but we received verbal feedback from visitors to the festival and around 20 suggestions were left in our suggestions box. The feedback was invariably positive: "This is an amazing event for the village, thank you", "Thank you very much for putting on gluten free bitters!!!". There were some specific suggestions for changes, which will be considered for the next festival.
