1. DEFINITIONS AND INTERPRETATION

This Deed shall be interpreted in accordance with paragraphs 1 (Definitions), 2 (Construction) and 3 (Third party rights) of the Schedule to

2. CREATION OF SECURITY

a. The Borrower shall pay or discharge the Secured Liabilities in the manner provided for in the Finance Documents.

b. All the security created under this Deed is:
