WHEREAS, management has been directed to notify all relevant stakeholders, including but not limited to shareholders, employees, and regulatory bodies, of the approved change in the Company's Articles and provide them with the updated version;

WHEREAS, the Board has confirmed and ratified all actions taken by management pursuant to the board resolution.

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1) The shareholders of CROSSIP Ltd hereby approve the adoption of the Proposed Articles as presented by the Board, incorporating new language that legalizes the Company's commitment to a positive impact on society and the environment, in line with the Company's ambition to become a BCorp company.
- 2) The shareholders acknowledge and support the actions of the Board and management in effectuating the change in the Company's Articles as outlined in the board resolution.
- 3) The shareholders authorize and empower the Board and management to take all necessary steps, sign and execute any documents, and undertake any actions required to implement the changes to the Company's Articles as approved.
- 4) The shareholders direct the management to provide regular updates on the progress of implementing the approved changes in the Company's Articles and to address any concerns or questions raised by the shareholders.
