Company activities and impact

Originally set up in 2020 as Wells Coronavirus Network to respond to the pandemic in 2020, Wells Community Network has been operating as a community interest company for the last since its formation, continuing to offer the services in response to Covid19. In addition to the weekly Core Group Meetings, we send out a weekly newsletter which reports on Network Partner news. We hold a fortnightly Network Partners meeting and a quarterly Board meeting. As a result of this strong network of organisations, WCN now provide a weekly gardening team at Wells Health Centre and were involved in the organisation of the Jubilee Celebrations' Cream Tea in the Cathedral Nave. Pandemic Response and Community HelplineWhen we started the helpline at the beginning of the pandemic, we didn't think for one minute we would still be operating today! The WCN helpline has been running for more than two years. Most of the volunteers, including the call handlers, request coordinators (WACS) and those who fulfil the requests, have been with us since the beginning. It's a brilliant team and we really appreciate their commitment, resilience and good humour. Over 750 residents of Wells and the local villages have been supported by the helpline. We have taken 4072 calls. We have delivered 1873 prescriptions. We have undertaken 1777 shopping trips. In addition, we have provided transport for many people to vaccination sites, GP appointments and hospital visits. Many people phone us just for a chat and we try to provide befriending calls for those who request them. Most importantly, we have signposted many other callers to appropriate organisations for further or specialist help. We are always looking for volunteers so please contact us if you would like to help. All support is valued; a couple of hours a week or flexible, one-off offers of support. Marshalling at vaccination centres and elsewhereIn 2021 we provided West Mendip Hospital with 150 marshals to run the COVID vaccination clinic. Working in partnership with the Mendip Primary Care Network between December 20 and June 21, 38,000 vaccinations were administered. Marshals have also been helping at Community Events - Wells Food Festival in October, The Crib festival at St Cuthbert's Church, and the Mistletoe and Wine in Wells Market Place both in December and we have been approached to see if we could provide marshals in September for a 5 and 10K run and in October for the Wells Food Festival. WCN core group worked hard to try to find a way of establishing a Covid vaccination clinic in Wells, meeting with the MP, speaking to different councils and we were eventually approached by Locking Pharmacy to marshal at a clinic at St Thomas Church Hall. This started in March and the people of Wells now have the opportunity to book a jab locally. So a huge thank you to all our volunteers who have given up their time to support these events, and support the community of Wells. Volunteering in the communityWe have a team of around 60 active volunteers who get involved in a whole range of activities from going shopping for people, collecting prescriptions and walking dogs. We have several volunteers who have shopped on a weekly basis for people since the beginning of the pandemic. Occasionally we are asked to give lifts to people who have difficulty in accessing public transport, who need help getting to a medical appointment.

Consultation with stakeholders

In the lead up to forming the CIC we consulted the people of Wells and our volunteer network and our partner organisations as to whether we should continue this service – this was undertaken using a questionnaire in both online format and as a printed document distributed to 6500 individual homes in the locality. The overwhelming response was a wish (i) to continue with services established during the pandemic; (ii) to create a coordinated volunteer network and (iii) for organisations to work and collaborate together. This informed the strategy for the new CIC. In addition, we have regular twice-monthly meetings with our network organisations, and frequent interaction with our phoneline and coordinating volunteers. We send out an annual Christmas card to service users and volunteers and ask for any comments and feedback. The annual AGM to which users and volunteers are invited is used as a further forum for consultation and feedback.
