

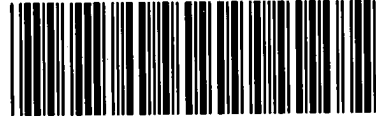

This applies from the day of application and before the day on which the application is finally dealt with or withdrawn.
