The company's social aim is 'to deliver outdoor learning opportunities to all'. The Company started delivering outdoor learning activities in September 2022. During the financial year 2022-23, the company's activities have benefited the community in the following ways:

- Delivered outdoor learning (Nature Play Sessions) to parent and toddler groups, providing a social focus for preschool aged children and their carers, whilst gaining from the health and wellbeing benefits of being in nature. Holistic opportunities to support physical, communication, social, emotional and cognitive development.
- Delivered a programme of regular outdoor learning sessions through two schools to over 720 children. Enhancing curriculum delivery, providing opportunity for long-term engagement with nature, developing social and emotional skills to enhance their holistic learning and skills for life.
- Provided opportunities for Coastal Schools to children who may not all have the opportunity to visit the local coast. Developing a sense of place and connection to the local environment.
- Employed 3 freelance workers two of whom are completing training, working within the company has allowed them to develop the skills required to deliver quality outdoor learning.
- Make improvements to environments within schools by working with the children to audit wildlife on site, create management plans and develop management programmes to improve habitats.
- Provided over 70 afterschool clubs to deliver Forest School, Gardening and Nature Play. This has provided opportunities for pupil premium children, looked after children.

The company's stakeholders are the schools involved, communities we service including the parents and children in the delivery areas. Landowners (schools, Devon County Council, Local Councillors, Northam Burrows Country Park) local nature charities (including North Devon Biosphere).

We work with schools to deliver a service which meets their needs so have meetings with the headteachers, I have also informally asked for feedback on the first year of session delivery within one of the schools at a staff meeting, this was positive. Over the next year with further feedback from the teaching staff we have integrated outdoor learning to link the classroom (or even replace) delivery to the outdoors, with hands on, practical application of the science curriculum.

With the children we review our delivery during/at the end of sessions or half termly, we listen to their needs and interests and develop sessions to incorporate these. This includes developing more outdoor cooking opportunities and development of wildlife habitat areas, we are looking to develop the facilities to offer more opportunities for the safe use of tools to make natural items using resources from our outdoor areas.

We haven't undertaken any formal consultation on the delivery of our services, through questionnaires or surveys. Due to the demand of the schools the uptake was more than we expected in the first year it meant we couldn't support our parent and toddler sessions, it is through the ongoing development of freelance staff that we are hoping to be able to develop these opportunities again. If we can use this as consultation we do have enquiries from parents that used to attend sessions and home educators that are wanting to use the services but the problem is finding appropriately trained staff to deliver sessions. We are looking at ways to offer apprenticeships/training and development opportunities, to expand the services we can offer.
