- (d) SPORTING INTERNATIONAL GROUP LTD RECEIVES 10,000 NEW ALLOTTED SHARES IN AJK GLOBAL HOLDINGS LIMITED IN EXCHANGE FOR THEIR 10,000 SHARES BEING TRANSFERRED TO AJK GLOBAL HOLDINGS LIMITED
- (e) FCL HEALTH SOLUTIONS LTD RECEIVES 4,724 NEW ALLOTTED SHARES IN AJK GLOBAL HOLDINGS LIMITED IN EXCHANGE FOR THEIR 4,724 SHARES BEING TRANSFERRED TO AJK GLOBAL HOLDINGS LIMITED
