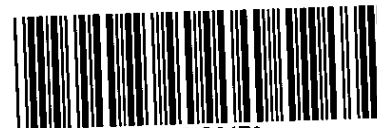



DESCRIPTION OF LIMITED AUTHORITY
