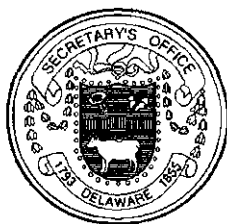



THIRD, the name under which the Corporation was originally incorporated is Black & Decker Investment Company.


