§ 7 Managing Directors

- (1) The Company has one or several managing directors

 - a) acquisition or disposal of real estate, rights relating to real estate or incurring an obligation to make such an acquisition or disposal as well as any construction measures pertaining to buildings,
 - b) the acquisition or disposal of participations in business enterprises as well as the conclusion, amendment or termination of cooperation or joint venture agreements,
 - c) the establishment or closing down of branch offices and operational locations.
 - d) the set-up of subsidiaries or affiliated companies,
 - e) the acquisition or manufacturing of tangible or intangible fixed assets with a value exceeding EUR 500 000,00,

- f) the granting and cancellation of general powers of attorney (General-vollmachten), registered powers of attorney (Prokuren) and specific powers of attorney (Handlungsvollmachten),
- g) all business activities or measures outside of the ordinary course of business of the Company,
- h) any other business activities or measures for which the Advisory Board established a consent requirement
