- (3) In den Fällen des § 47 (4) GmbH-Gesetz steht dem betreffenden Gesellschafter ein Stimmrecht nicht zu.

§ 9

#### ACD-Elektronik GmbH

§ 1

#### Company, headquarters

- (1) The company is called ACD-Elektronik GmbH.
- (2) The company's headquarters is in Achstetten.

§ 2

#### Corporate purpose

The corporate purpose is the operation of a company for the representation, development, and manufacturing of electrical and electronic systems. The company may take over, represent, and participate in companies of the same or similar type.

§ 3

#### Beginning, duration, fiscal year

- (1) The company begins legally with its entry into the commercial register; its duration is undetermined.
- (2) The fiscal year is the same as the calendar year.

#### Capital stock

The capital stock of the company is EUR 1,000,000.00 (one million euros).

§ 5

#### Assignment, encumbrance of shares

- (1) The sale of shares or parts of shares is only permitted to co-shareholders, spouses, and children of shareholders' marriages. § 17 GmbH law remains unaffected.
- (2) The encumbrance and pledging of shares of the company by the shareholders is not permitted.

§ 6

#### Redemption of shares

- (1) The redemption of shares is possible at any time with agreement of the shareholder.
- (2) The redemption of shares is possible without permission of the shareholder in question if
- a) the share was seized by a creditor of the shareholder.
- b) bankruptcy proceedings or judicial settlement proceedings have been instituted against the shareholder's assets
- c) a shareholder has violated the company's interests in a grossly negligent manner, especially if a shareholder behaves in competition with the company or discloses trade secrets.

The share redeemed is to be compensated at fair market value. In case of seizure, the company has the right to satisfy the executing creditor and to pay the amount expended as compensation. §33 GmbH law remains unaffected.

(3) Instead of redeeming, the shareholders' meeting can decide that the shareholder in question must cede his share to the remaining shareholders in equal parts. The person ceding the share must be paid the common value of the share ceded.

§ 7

### Senior management

- (1) The company has one or multiple Managing Directors. If there are multiple Managing Directors present, the company is represented jointly by two Managing Directors. The shareholders' meeting can grant Managing Directors individual authority to act and free them from the restrictions included in §181 BGB.
- (2) The Managing Directors must conduct the company's business according to the provisions of the law, the articles of incorporation, and the employment contract. In addition, the Managing Directors are obligated to heed instructions from the shareholders' resolutions.
- (3) Managing Directors can only be recalled in cases of § 6 Para.2 c.

#### Shareholders' meeting. Voting right

- (1) The shareholders shall resolve in the cases provided for by law and the articles of association.
- (2) Shareholder resolutions require in all cases a majority of 65% of the votes cast. Voting is determined by shares, whereby one vote is granted per 1,000 DM of a company share.
- (3) In cases of the § 47 (4) GmbH law, the affected shareholder does not have a right to vote.

§ 9

- (1) The annual accounts must be created within the first three months of the ongoing fiscal year for the past fiscal year with profit and loss calculation and presented to the shareholders' meeting for resolution. For the creation of the annual accounts, the legal provisions and basic principles of proper bookkeeping must be heeded.
- (2) The shareholders' meeting decides about the formation of accruals and reserves. It also decides about the payment of dividends. The shareholders receive a portion of the profits in proportion to their shares.

§ 10

#### **Announcements**

The company's announcement shall be made in the Staatsanzeiger des Landes Baden-Württemberg or in a substitute paper in its place.

#### General

- (1) Insofar as nothing else is determined in the company's articles of incorporation, the provisions of the law governing limited liability corporations apply for the corporate relationship. If individual provisions of the articles of incorporation are legally invalid, the validity of the rest of the other provisions of the articles of incorporation is not affected by this. The invalid provision must be reinterpreted or supplemented so that the economic purposes intended with the invalid provision is achieved.
- (2) The company will pay the notary and court costs arising due to the establishment of the company, as well as the taxes due and other fees.
- (3) Place of fulfillment and court of jurisdiction for all disputes arising from this contract is the court responsible for the company's headquarters.

§12

#### Exemption from the non-competition clause

If a shareholder or Managing Director in relationship to the company is subject to a non-competition clause, the shareholders' meeting can decide, through resolution that is passed with simple majority of the votes cast, to free the shareholder or Managing Director generally or in a specific case from the non-competition clause and in this context to make any necessary additional regulations about task delimitation and if necessary agreement on compensation.
