- Textron, Inc Master Trust transferred 100% of its interest in the Partnership, including 100% of its capital contribution amounting to EURO 155, to ASF Phantom L.P., and consequently Textron, Inc Master Trust ceased to be a limited partner of the Partnership and held a capital contribution of EURO 0
- As a consequence of the transfers detailed above, ASF Phantom LP holds a capital contribution of EURO 344 34
