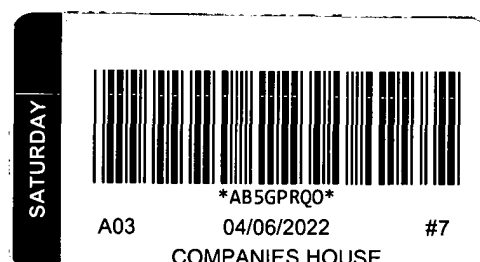

During the current financial period, the Partnership was active as trade agent for industrial machinery and equipment and received commission.
