AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of His Majesty to  
the relief sought by this Claim as appears from the waiver letter from the Treasury  
Solicitor dated the 19th May 2022

AND ON the leave of the Court being given to amend the Claim Form (i) by  
particularising the Claimant's address (2) by replacing the LLP as Defendant with the  
Registrar of Companies and (3) by particularising the relief sought under Section  
1029 of the Companies Act 2006 seeking an Order to restore the name of the LLP to  
the Register of Companies, and re service being dispensed with

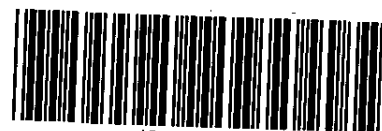
AND UPON the Claimant by his solicitors undertaking to:

(A) inform the Registrar of Companies of the title and Court reference number of  
the proposed litigation against the LLP seeking to recover a loan made to  
the LLP referred to in paragraphs 7 to 9 of the Witness Statement of  
Benjamin James Wells dated the 21 February 2022 immediately after issue

(B) inform the Registrar of Companies immediately on the conclusion of the  
litigation insofar as is it against the LLP or of any appeal therefrom or on the  
conclusion of the claim against the LLP

(C) in the absence of any award of the Court arising out of the proposed litigation referred to in undertaking (A) being satisfied within 42 days of such award, immediately present a Petition to the Court seeking the compulsory winding up of the LLP

(D) inform the Registrar of Companies of the title and Court reference of the proposed Petition immediately after issue

(E) inform the Registrar of Companies immediately on the outcome of the said Petition

(F) within 21 days of an Order being made to compulsorily wind up the LLP serve a copy of that Order on the Registrar of Companies within 21 days thereafter

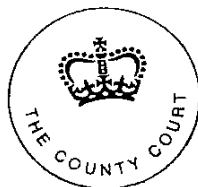
(G) inform the Registrar of Companies immediately on the conclusion of the Claimant's claim against the LLP if by any other means

AND UPON the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

(1) the name of the above named Kingfield Alliance LLP be restored to the Register of Companies

(2) if at the date of registration of this Order with the Registrar of Companies the name of the LLP is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the LLP to OC322497 LLP



(3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the LLP is thereupon to be deemed to have continued in existence as if its name had not been struck off

(4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"

(5) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300-00


(6) the hearing fixed for the 23 February 2023 at 2:00 pm be vacated
