During the current financial period, the company was active as trade agent for computer parts and accessories and received commission.

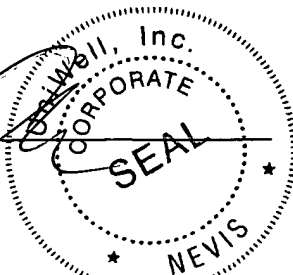
NOTE

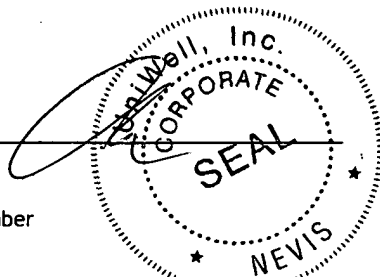

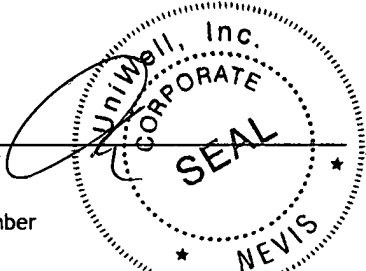
