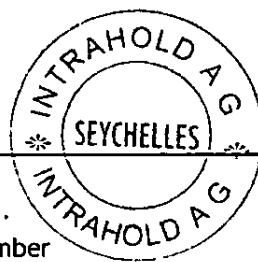
RESPONSIBILITY

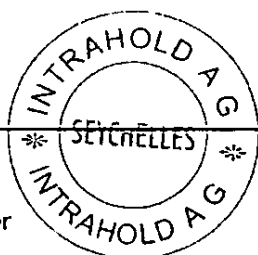

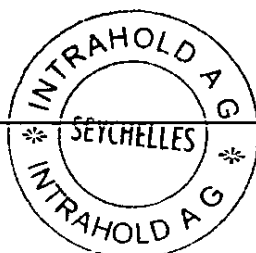
