During the current financial period, the company was active as trade agent for communication equipment and received commission

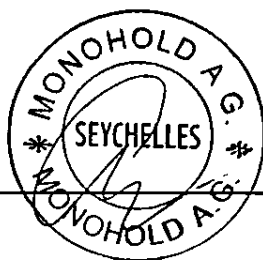
**NOTE**

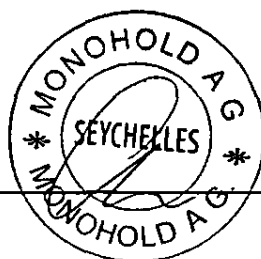

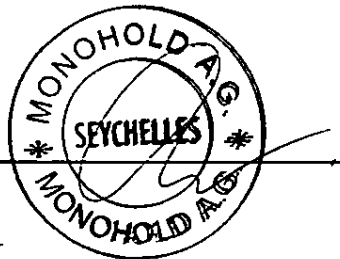
