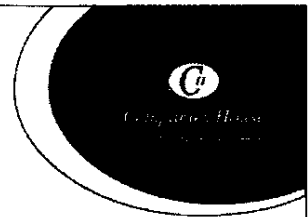

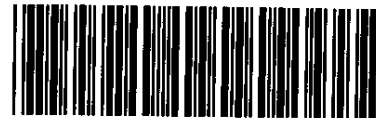

Notify all parties

Withdrawal of striking off application by a LLP
