The Partnership registered 29 October 2009 under Registered Company No. OC349664. The registered office address is at 13 John Prince's Street, 2nd Floor, London, England, W1G OJR.

PRINCIPAL ACTIVITY & REVIEW OF BUSINESS

During the current financial period the Partnership was active as a holding company which holds the shareholding (69.4%) in SZAO "Asfaltobetonnij Zavod" (Асфальтобетонный завод), reg. no.: 191115757, a Belarusian company. Classmond Trade LLP accumulates profit generated by SZAO "Asfaltobetonnij Zavod". SZAO "Asfaltobetonnij Zavod" operates asphalt production facility in the City of Minsk. The company is a taxpayer in Belarus and its income is subject to income taxation in the Republic of Belarus.

NOTE

The Partnership primarily conducts business in foreign currencies, such as US Dollars and Euro. Assets and liabilities in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are translated into sterling at the rate of exchange ruling at average rate during the period. Exchange differences are taken into account in arriving at the operating result.

Trade and other receivables include creditor claim to ABLV Bank, LAS (Latvia) in amount GBP 60,054 (Sixty thousand fifty-four Pound).

The members are required by Company Law to prepare accounts for each financial year which give a true and fair view of the state of affairs of the Partnership as at the end of the financial year under review and of the result of that period and deliver the same to the registrar.
