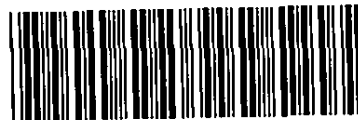



## 4 What to do next

### Notify all parties
