Business Review


The Company is dormant and has not traded during the year therefore no profit and loss account or cash flow statement is included in these financial statements.



Notes to the Financial Statements for the Year Ended 30 June 2023

1 Accounting policies

General information

The limited liability partnership is incorporated in England and Wales under the Limited Liability Partnership Act 2000. The address of the registered office is given on the limited liability partnership information page. The nature of the limited liability partnership's operations and its principal activities are given in the members' report.

Statement of compliance

These financial statements have been prepared in accordance with applicable United Kingdom accounting standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland' ('FRS 102'), Companies Act 2006 as applied by LLPs and the Statement of Recommended Practice (SORP), Accounting by Limited Liability Partnerships, issued in 2017. These financial statements have been prepared using the historical cost basis.

2 Ultimate controlling party

The partners of the LLP are Kier Foley Street Holdco 1 LLP and Kier Foley Street Holdco 2 LLP. Kier Foley Street Holdco 1 LLP owns 99.9% and Kier Foley Street Holdco 2 LLP owns 0.1%.

The ultimate joint venture partners; Kier Property Developments Limited who owns 90% and Investec Investments (UK) Limited who own 10% have common control and as such results are not consolidated in either partner's financial statements.

Both the partners are registered in England and Wales and copies of their financial statements can be obtained from Companies House, Crown Way, Cardiff.
