Joint Administrators comments

The SOA as at 10 August 2018 was submitted on 6 September 2018. We would comment that the estimated realisable value attributed to a number of assets are based upon subjective assumptions made by the HOFL directors and therefore could be higher or lower than indicated. Similarly, creditor claims may differ from those indicated.

Additionally, the estimated to realise values are shown before allowance for applicable costs of realisations.

We have provided below specific comments in respect to the SOA.

Unsecured creditors

Unsecured creditors per the SOA total c.£182m in respect to intercompany payables. We have not been able to verify the quantum of this. The most recent financial statements, dated 28 January 2017, include £5.1m other creditors and accruals. The SOA does not include a similar related creditor balance.
