#### 1 QUORUM AND NOTICE

- 1.1 It was agreed that John Fraser Haran should act as Chairman of the Meeting.
- 1.2 It was reported that notice of the Meeting had been given to all directors entitled to attend and that a quorum was present.

#### 2 PURPOSE

2.1 The Chairman explained that the purpose of the Meeting was to consider the financial position of the Company and whether it would be appropriate for the Company to appoint Benjamin James Browne; Elizabeth Galbraith Mackay; and Catherine Mary Williamson, all of AlixPartners Services UK LLP (the "Administrators") as joint administrators of the Company, with a view to the Administrators achieving a better result for the Company's creditors as a whole than would be likely if the Company were wound up.

#### 3 DECLARATIONS OF INTEREST

- 3.1 Each of the directors present declared their interest in the business of the Meeting in accordance with sections 177 and 182 of the Companies Act 2006 (the "Act") and the articles of association of the Company.
- 3.2 Having declared their interests, it was noted that, in accordance with the articles of association of the Company and the Act, the directors were entitled to attend and vote at this meeting and to be counted in the quorum.

3.3 The Chairman confirmed that he had been appointed by Lindsay Elizabeth Mary Haran, John William Haran, & Sarah Haran as their alternative director of the Company.

#### 4 DOCUMENTS PRODUCED TO THE MEETING

- 4.1 The following documents were produced to the Meeting for consideration:
  - 4.1.1 current financial information of the Company;
  - 4.1.2 correspondence and advice provide by external consultants advising the Company;
  - 4.1.3 Group assessment of Company cash flow projections (together the "Documents").

#### 5 CONSIDERATION OF THE COMPANY'S FINANCIAL POSITION

- 5.1 The directors considered the latest financial position of the Company, in particular the following:
  - 5.1.1 the Company has identified an overstatement in both sales and WIP in the audited accounts to the year end (31 March 2017) and the management accounts to July;
  - 5.1.2 the restatement impact of these matters on the audited accounts to 31 March 2017 will be £1.84m;
  - 5.1.3 the restatement impact of these matters on this year's management accounts to July will be £235,000, which results in a loss for the year from April to July of £149,000;
  - 5.1.4 the Company's monthly accounts for August indicate a further loss of £86,000 with the expectation of further losses from September to November of £89,300
  - 5.1.5 the Group's assessment of the Company's current trading cash flow projections to 31st March 2018. This assessment indicates a maximum month end overdraft position of £1,089,000 in March 2018. This is in excess of the current Company overdraft limit of £750,000;
  - 5.1.6 the Group's assessment of the Company's current trading cash flow projections to 31st March 2019. This assessment indicates a maximum month end cash position of £1,615,700 in December 2018 This is in excess of the current Company overdraft limit of £750,000;

6.2.6 the Administrators be appointed as joint administrators of the Company with all powers to comprehensively conduct the administration under the Insolvency Act, such appointment being subject to compliance with the appointment formalities of the Insolvency Act – with such powers to be exercised jointly and severally by the Administrators.
