STRATEGIC REPORT

FOR THE YEAR ENDED 31 MARCH 2023

The directors present the strategic report and financial statements for the period ended 31 March 2023.

Fair review of the business

Archangel Investors Limited assesses and vets investment opportunities and carries out due diligence and other portfolio management services on behalf of our investors. All regulated activities in connection with the business of Archangels are carried out by Archangels Investors (Management) Limited, a subsidiary of Archangel Investors Limited, which is authorised and regulated by the Financial Conduct Authority.

2022/23 was another exceptionally busy year for our syndicate.

We arranged investment totalling £25.1m (2021/22: £27.7m) over eleven investment rounds during the financial year, of which £11.2m came from Archangels members.

We had one substantial exit during the year, with the sale of Blackford Analysis to Bayer Pharma, which had been in our portfolio since 2012. While we cannot disclose the detailed terms because of confidentiality obligations, the money multiple and IRR on our investment were strong. In addition to the exit of Blackford Analysis, we continued to receive dividend income from one of our portfolio companies and we received 100% of the escrow which was held back for 12 months, following the sale of Optoscribe.

On a corporate level, I am pleased to report that our investor base has remained steady at 107 during the year (2021/22: 107). Our investors are fundamental to Archangels' activities and without their ongoing support for what we do, we could not continue to provide the significant levels of investment in money and time to our companies.

Key Performance Indicators

Key performance indicators are measured and reviewed on a regular basis to enable the business to set its performance targets and monitor its performance against these targets. Our primary target relates to providing an excellent level of service for our investors and is measured by reference to investor retention. It is important that we retain a strong market presence and that our investment approach is well understood so that we maintain an adequate flow of high-quality investment opportunities for our members. In this respect, our new deals committee monitors the number and quality of investment opportunities and business plans that we receive each year.

Our investors invest significant amounts each year and we endeavour to actively manage the investee portfolio in order to return cash to investors by way of exits. However, the board does not consider it appropriate to set specific KPIs in these areas. However, we do set specific targets in relation to working capital and debtor collection within our own business, which we have successfully achieved during the period.

Key risks

The Board determines the Company's business strategy and risk appetite along with designing and implementing a risk management framework that recognises the risks that the business faces, both presently and in the future. They also determine how those risks may be mitigated and assess on an on-going basis the arrangements to manage those risks.

The Board considers business planning and risk management on a regular basis. This includes managing the Company's risks though a framework of policy and procedures having regard to relevant laws, standards, principles and rules with the aim of operating a defined and transparent risk management framework. These policies and procedures are updated as required. The Company has an operational infrastructure appropriate to its size.

Currency risk

Archangels' receives income from investee companies through research fees and monitoring fees. These are paid in sterling. Whilst the Company does have some indirect exposure to currency through performance fees paid on a successful exit where the exit consideration is not sterling denominated, the exposure is immaterial to the Company's financial position.

Market risk

Market risk is the risk of any impact upon the Company's financial condition due to fluctuations in values of, or income from, assets or in interest or exchange rates. The Company does not take positions which materially expose it to market risk.

Investment Risk

The Company facilitates the investment activity of its investors in disruptive, early-stage technology companies based in Scotland. It is inherent in the nature of the company's activities that some investments will be made which will ultimately be loss making. Such losses impact on the level of performance fees and could, in the long term, impact the Company's track record and its ability to retain and recruit new investors. The Company has put in place rigorous due diligence procedures for all investment rounds to mitigate this risk.

Credit risk

Credit risk relates to risk of non-payment by investee companies of monitoring fees. Monitoring fees comprise a small proportion of the overall income of the Company each year.

Liquidity risk

Liquidity risk is defined as the risk that the Company, although solvent, either does not have sufficient available resources to enable it to meet its obligations as they fall due, or can secure them only at excessive cost.

The Board regularly monitors cash flow and management accounts to ensure that the Company maintains adequate working capital.

Operational risk

Operational risk, inherent in all businesses, is the potential for financial and reputation loss arising from failures in internal controls, operational processes or systems that support them. It includes errors, omissions, disasters and deliberate acts such as fraud. The environment in which the Company operates imposes extensive reporting requirements and continuing self-assessment and appraisal. Internal arrangements and processes are in place to reevaluate continually as the Company seeks to improve its operating efficiencies and these are considered to have been effective to date.

Board and Investor Succession

The Company relies on its board and investors to provide investment capital, oversight, domain expertise and mentoring to investee companies. These are important aspects of the business angel syndicate. The Company has a strategy in place to recruit new investors with appropriate skills.

Dependence on key technical personnel

The Company's success is driven by its key technical staff in providing services to its target market. Therefore the Board consider a key risk to be the loss of its key staff and the retention of these individuals is a key objective of the Company through having competitive remuneration policies.

Section 172 Statement

The Directors have a duty to promote the success of the Company for the benefit of its members and to describe how they have performed this duty having regard to matters set out in section 172(1) of the Companies Act 2006. In fulfilling this duty, the Directors consider the likely consequences of their actions over the long term and on other stakeholders.

The Company and wider group are committed to being a responsible business, providing regular opportunities for employee feedback and suggestions. The group aims to foster a positive working environment which is enforced by regular team meetings.

The Company is committed to developing and maintaining strong relationships with its customers and suppliers. Management are in frequent contact with the Company's suppliers to discuss and plan for future service requirements and ensure the company is receiving the best possible service and value.

Management arrange a number of regular events for our investors and maintain regular dialogue with them throughout the year. Management is also in regular contact with investee company representatives through attendance at monthly board meetings and regular contact in between.

The Directors are conscious of the impact the Company's operations have on the community and the environment and aims to minimise environmental disruption from its activities. The Company is always looking for ways in which it can reduce its carbon footprint.

The Board are committed in their day to day operations and dealing with stakeholders, to uphold the highest standard of business integrity and conduct. If there are any concerns with the standard of conduct then this will be actively raised and discussed at board meetings.

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 MARCH 2023

1 Accounting policies

Company information

Archangel Investors Limited is a company limited by guarantee incorporated in Scotland. The registered office is Suite 2. Ground Floor Orchard Brae House, 30 Queensferry Road, Edinburgh, EH4 2HS.

1.1 Accounting convention

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006.

The financial statements are prepared in sterling, which is the functional currency of the company. Monetary amounts in these financial statements are rounded to the nearest £.

These consolidated and separate financial statements are prepared on a going concern basis, under the historical cost convention, as modified by the recognition of certain financial assets and liabilities measured at fair value. The principal accounting policies adopted are set out below.

1.2 Basis of consolidation

The consolidated profit and loss account and balance sheet include the financial statements of the company and its subsidiary undertakings made up to 31 March 2023. The results of subsidiaries sold or acquired are included in the profit and loss account up to, or from the date control passes. Intra-group sales and profits are eliminated fully on consolidation.

1.3 Going concern

The Directors and Management have assessed the company's activities and the appropriateness of the use of the going concern basis. The company has not faced any material changes to its activities during the period and does not expect any material impact on its revenues or costs. In addition, the company operates a prudent cash reserves policy which would give it sufficient time to make any changes required to its business if it were at any point to face material adverse trading conditions. Thus the Directors consider it is appropriate to continue to adopt the going concern basis of accounting in preparing the financial statements.

1.4 Turnover

Turnover is recognised at the fair value of the consideration received or receivable for goods and services provided in the normal course of business, and is shown net of VAT and other sales related taxes. The fair value of consideration takes into account trade discounts, settlement discounts and volume rebates.

When cash inflows are deferred and represent a financing arrangement, the fair value of the consideration is the present value of the future receipts. The difference between the fair value of the consideration and the nominal amount received is recognised as interest income.

1.5 Judgements and key sources of estimation uncertainty

In the application of the company's accounting policies, the director is required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

1 Accounting policies

1.6 Tangible fixed assets

Tangible fixed assets are initially measured at cost and subsequently measured at cost or valuation, net of depreciation and any impairment losses.

Depreciation is recognised so as to write off the cost or valuation of assets less their residual values over their useful lives on the following bases:

Fixtures, fittings & equipment

25% straight line

Computer equipment

33.3% straight line

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, and is credited or charged to profit or loss.

1.7 Fixed asset investments

Interests in subsidiaries, associates and jointly controlled entities are initially measured at cost and subsequently measured at cost less any accumulated impairment losses. The investments are assessed for impairment at each reporting date and any impairment losses or reversals of impairment losses are recognised immediately in profit or loss.

A subsidiary is an entity controlled by the company. Control is the power to govern the financial and operating policies of the entity so as to obtain benefits from its activities.

1.8 Impairment of fixed assets

At each reporting end date, the company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). Where it is not possible to estimate the recoverable amount of an individual asset, the company estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

Recognised impairment losses are reversed if, and only if, the reasons for the impairment loss have ceased to apply. Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash-generating unit) prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried in at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

1.9 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks, other short-term liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities.

1 Accounting policies

1.10 Financial instruments

The company has elected to apply the provisions of Section 11 'Basic Financial Instruments' and Section 12 'Other Financial Instruments Issues' of FRS 102 to all of its financial instruments.

Financial instruments are recognised in the company's statement of financial position when the company becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

Basic financial assets

Basic financial assets, which include trade and other receivables and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest.

Other financial assets

Other financial assets, including investments in equity instruments which are not subsidiaries, associates or joint ventures, are initially measured at fair value, which is normally the transaction price. Such assets are subsequently carried at fair value and the changes in fair value are recognised in profit or loss, except that investments in equity instruments that are not publically traded and whose fair values cannot be measured reliably are measured at cost less impairment.

Impairment of financial assets

Financial assets, other than those held at fair value through profit and loss, are assessed for indicators of impairment at each reporting end date.

Financial assets are impaired where there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows have been affected. If an asset is impaired, the impairment loss is the difference between the carrying amount and the present value of the estimated cash flows discounted at the asset's original effective interest rate. The impairment loss is recognised in profit or loss.

If there is a decrease in the impairment loss arising from an event occurring after the impairment was recognised, the impairment is reversed. The reversal is such that the current carrying amount does not exceed what the carrying amount would have been, had the impairment not previously been recognised. The impairment reversal is recognised in profit or loss.

Derecognition of financial assets

Financial assets are derecognised only when the contractual rights to the cash flows from the asset expire or are settled, or when the company transfers the financial asset and substantially all the risks and rewards of ownership to another entity, or if some significant risks and rewards of ownership are retained but control of the asset has transferred to another party that is able to sell the asset in its entirety to an unrelated third party.

Derecognition of financial liabilities

Financial liabilities are derecognised when the company's contractual obligations expire or are discharged or cancelled.

1 Accounting policies

1.11 Taxation

The tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from net profit as reported in the profit and loss account because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The company's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the reporting end date.

Deferred tax

Deferred tax liabilities are generally recognised for all timing differences and deferred tax assets are recognised to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits. Such assets and liabilities are not recognised if the timing difference arises from goodwill or from the initial recognition of other assets and liabilities in a transaction that affects neither the tax profit nor the accounting profit.

The carrying amount of deferred tax assets is reviewed at each reporting end date and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered. Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised. Deferred tax is charged or credited in the profit and loss account, except when it relates to items charged or credited directly to equity, in which case the deferred tax is also dealt with in equity. Deferred tax assets and liabilities are offset when the company has a legally enforceable right to offset current tax assets and liabilities and the deferred tax assets and liabilities relate to taxes levied by the same tax authority.

1.12 Employee benefits

The costs of short-term employee benefits are recognised as a liability and an expense, unless those costs are required to be recognised as part of the cost of stock or fixed assets.

The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Termination benefits are recognised immediately as an expense when the company is demonstrably committed to terminate the employment of an employee or to provide termination benefits.

1.13 Retirement benefits

Payments to defined contribution retirement benefit schemes are charged as an expense as they fall due.

1.14 Leases

Rentals payable under operating leases, including any lease incentives received, are charged to income on a straight line basis over the term of the relevant lease except where another more systematic basis is more representative of the time pattern in which economic benefits from the lease asset are consumed.
