The group of subscribers and individuals who make up the unique property syndicates started the original entity in 1998. In the 21 years since then, 24 building renovation projects have been completed. To date, over 111 new jobs have been created.

The current nomenclature of "Unique Property Syndicates Ltd" was provided and preserved via a change of name event for this company (SC403621) on 29th October 2014.

However, each unique property is bought by a stand-alone and dedicated limited liability company; the asset/liability and accountancy elements are all ring-fenced to help demarcate the financial and precise ownership structures of each project. The Unique Property Syndicates Ltd., entity has been primarily for project management coordination, research and administration purposes and not direct property ownership within this specific company number SC403621. Therefore, with effect from 1st January 2018, the subscribers of this company took the decision that all administrative and project management functions will be for each respective, stand-alone building-owning company to undertake.

Consequently, from 1st January 2018 (inclusive of that date) this company, Unique Property Syndicates Ltd., is being placed into a dormant state in terms of the Companies Act.
