### **Liquidator's report to the final meeting of creditors**

#### **1. Introduction**

Derek Forsyth, Campbell Dallas, Titanium 1, King's Inch Place, Renfrew, PA4 8WF was appointed Interim Liquidator of Active Energy Savers Limited by the Sheriff at Lanark Sheriff Court on 22 July 2015 following the presentation of a petition to the Court on 18 June 2015. He was subsequently appointed Liquidator at the statutory meeting of creditors held on 1 September 2015.

Derek Forsyth is the Liquidator of the Company and this is his report to the creditors of the Company showing how the liquidation has been conducted for the whole period of the liquidation.

#### **2. Statutory Information**

Statutory information relating to the Company is attached at Appendix I.

#### **3. Liquidator's Receipts and Payments Account**

A summary of the Liquidator's receipts and payments account for the relevant period from 18 June 2020 to 12 August 2020 is attached at Appendix II.

#### **4. Action taken by the Liquidator**

No assets were realised during the course of the liquidation.

All statutory documentation has been prepared by the liquidator during the course of the liquidation.

#### **5. Investigations**

The Liquidator has a duty to submit confidential reports to the Government's Disqualification Unit on the conduct of those persons who acted as directors of the Company in the three year period before the liquidation. I can confirm that I have complied with my duties in this regard.

Following the submission of the report, Gordon Glen, the Director, was disqualified from acting as a Director of any Company for a period of 8 years.

#### **6. Liabilities and Dividends**

There were insufficient realisations to enable a payment to be made to any class of creditor.

#### **7. Liquidator's Remuneration, Disbursements and Expenses**

As no assets were realised during the course of the liquidation the costs and outlays of liquidation have been met by a third party.

## 8. Conclusion of the Liquidation

The affairs of the company are now fully wound up. Formal notice that the Liquidator intention to seek his release is attached.
