

# Liquidator's report to the final meeting of creditors

### 1. Introduction

Derek Forsyth, Campbell Dallas, Titanium 1, King's Inch Place, Renfrew, PA4 8WF was appointed Interim Liquidator of Active Energy Savers Limited by the Sheriff at Lanark Sheriff Court on 22 July 2015 following the presentation of a petition to the Court on 18 June 2015. He was subsequently appointed Liquidator at the statutory meeting of creditors held on 1 September 2015.

Derek Forsyth is the Liquidator of the Company and this is his report to the creditors of the Company showing how the liquidation has been conducted for the whole period of the liquidation.
