1 Statutory information

DS KILTS & SOUVENIRS WHOLESALE LTD. is a private company, limited by shares, registered in Scotland, registration number SC419907. The registered office is 6 WARRISTON TERRACE, EDINBURGH, EH3 5LZ.

2 Compliance with accounting standards

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

3 Accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out below and have remained unchanged from the previous year, and also have been consistently applied within the same accounts.

Basis of preparation
