#### 2. FINAL REPORT

#### 2.1 Background

Solehya Limited was incorporated on 10 December 2015. The company traded from leased premises at 28 Gordon Street, Glasgow, G1 3PU. The registered office of the company is 14 Menzies Avenue, Fintry, Stirling, G63 0YE. The company's principal activity was that the trading of a 'Shakeaway' franchise selling milkshakes and other snacks.

#### 2.2 Actions on Appointment

Upon my appointment I initiated contact with the company director Mr Fowlds, who confirmed that the company had ceased trading on 26 August 2017. Mr Fowlds confirmed that the trading premises at 28 Gordon Street had been vacated and the landlord had a new tenant in place. A visit from my staff has confirmed that the company is no longer trading from the premises.

Mr Fowlds confirmed that all assets of the company, being the equipment and fixtures and fittings from the store, had been sold to Shakeaway, the franchisor, for the sum of £5,000 plus VAT. The appointed Liquidator will carry out investigations to ensure that fair value was paid for the assets.

#### 2.3 Investigations

The company banked with HSBC Bank and at the date of my appointment there were no funds held in the bank account. Walker Love Sheriff Officers were holding funds of £6,000 in respect of an arrestment made prior to my appointment. It was confirmed that these funds were unable to be realised in the liquidation.

I have complied with my statutory duties in the liquidation, including my responsibilities for reporting to the Insolvency Service on the conduct of the director.

### 2.4 Creditors

HM Revenue and Customs have submitted a claim totalling £253.99 and Glasgow City Council have submitted a claim for £15,731.55 in respect of rates.
