PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

2020/2021 has been a year that will remain comparable to no other. A total of seven months of the year were spent in national lockdowns due to the Covid pandemic. We had some ground-breaking firsts when it came to accessible NGB's for staff training and as an organisation began to take bookings in other activity areas such as guided wheelchair walks, the Duke of Edinburgh Award expeditions, packrafting taster sessions and winter skills courses for disabled adults. It is through the governments Furlough scheme and the organisations low overheads that we were able to come through this financial year unscathed. Bookings were cancelled but the enthusiasm and interest from disabled clients steadily increased. This meant that the Wheelchair Adventure Race has been postponed and our involvement with the Cairngorms Big Nature Weekend and Scottish Orienteering Accessible Event were all cancelled too. However, despite all of this, we have still been successful in our grant applications for activity equipment.

We are pleased to say that we still managed to secure grant funding from five organisations throughout the financial year. These include £2000 from the WMann Foundation for the purchase of wetsuits, £6000 from Crerar Hotels for the purchase of paddleboards, £500 from Alpkit for ice axes and crampons, £3000 to supporting a pathway into local canoe clubs for disabled people and £7000 from Trefoil House towards paddle sports equipment. We have been able to start spending the funds from each of these grants, despite delays in delivery and restrictions on the running of activity sessions.

Even though it was limited we have taken a couple of bookings throughout the year, these were for paddleboarding and a guided wheelchair walk. However, it is through the Furlough scheme, the pausing of our AALA license and the renewal of our DofE license for free that has really enabled us to stay afloat during the pandemic. It is clear from our accounts that our income was certainly limited and the majority of our cashflow was connected to the Furlough scheme and the acquiring and spending of grants. Although not what we anticipated, it has reassured us that our overheads as an organisation are extremely manageable as bookings ebb and flow and that with all the enquiries pre and during the pandemic we will be in a much stronger financial position in 2022.

It's not been the easiest of years for the disability community but now more than ever we are determined to continue to offer opportunities to access nature and adventurous activities as it has been proven that when you take away every other service the simple action of getting outside is vital to our physical and mental wellbeing.

We held one meeting and one AGM, due to the organisation being closed for 7 months on the Furlough scheme. The focus of these meetings was on how to move forwards with the government restrictions and what the needs of the disability community were as a result of the pandemic. As such it was felt the organisation needed to focus on the local disabled community and courses that would empower and enable disabled people to get outside and be active.
