Company activities and impact

The company has developed, operated and maintained RecipeRadar (<https://www.reciperadar.com>), a free search engine and meal planner available to the public. During 2020, RecipeRadar handled thousands of ingredient-based searches for recipes, and as of August 2021 it features an index linking to more than fifty thousand unique recipes around the world wide web. Development of the service has led to sharing of technical fixes and improvements in a variety of third-party free and open source (FOSS) community projects developed by other groups, including Google's "lighthouse" website performance auditing tool, and "html2canvas", a library to capture images from websites within a web browser. The RecipeRadar service is committed to providing forever-free recipe search and meal planning to the public, and uses second-hand self-hosted commodity computing hardware to maintain minimal operating costs. RecipeRadar is currently in maintenance mode -- continuing to provide free service to users -- while the sole director is engaged in full-time employment.
