



1 Accounting policies

These financial statements were prepared in accordance with Financial Reporting Standard 102 *The Financial Reporting Standard* applicable in the UK and Republic of Ireland ("*FRS 102*") as issued in August 2014. The presentation currency of these financial statements is sterling. The financial statements are prepared on the historical cost basis.

2 Ultimate parent company

The immediate parent company is Forest Holidays Limited (registration no. 08159308) which is 100% owned by Forest Holidays Group Limited (registration no. 08159281). Both companies are incorporated in England and Wales and their registered office is Bath Yard, Bath Lane, Moira, Derbyshire, DE12 6BA. Forest Holidays Group Limited is ultimately owned by Canopy Holdco Limited (registration no. 11070222) which is the parent undertaking of the smallest and largest group of the undertaking to consolidate the financial statements at 28 February 2021. The consolidated financial statements of all the accounts are available to the public and may be obtained from the Registrar of Companies, Companies House, Crown Way, Cardiff, CF14 3UZ.
