#### 1 Accounting policies

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the financial statements

#### Basis of preparation

The financial statements are prepared in accordance with applicable accounting standards and under the historical cost accounting rules

#### Cash flow statement
